## **UPDATE ON CASH & LISTED INVESTMENTS POSITION**

Following the recent execution of a \$5 million loan facility (see ASX Release dated 2 April 2012), Metallica Minerals Limited (ASX – MLM) is pleased to provide an update on its available cash position and approximate value of the Company's ASX-listed investments as at market close on Thursday 12 April 2012. Similar updates will continue to be issued periodically.

Total available cash is approximately \$14.5 million if the \$5 million debt facility (repayable 2 April 2013) is fully drawn down – currently only \$1 million has been drawn.

Metallica's cash and listed share investments currently total approximately **A\$39.6 million** compared to the Company's current market capitalisation of around **A\$34 million**. The MetroCoal shareholding has a current market value of around **A\$24 million**.

In addition, Metallica also has substantial mineral project asset value in its 100% owned **NORNICO nickel-cobalt & scandium project** in North Queensland, plus advanced **zirconrutile Heavy Mineral Sand projects** – Urquhart Point in Cape York and Gippsland (Option to Purchase 100%) in Victoria.
